The Mediterranean Women's Fund: women's fund (2008)

Goal: to strengthen the women's movement in all the countries of the Mediterranean region by:

- Funding women's and feminist organizations;
- Supporting new generations of women activists;
- Building bridges and strengthening networks;
- Advocating for more financial resources for women's and feminist organizations (institutions and private donors).







Is part of the CERV-2023-DAPHNE program (Citizens, Equality, Rights and Values) of the European Union.

- It aims at funding actions carried out by women's and feminist organizations that tackle gender-based violence (GBV).
- It seeks to support and develop open, rights-based, democratic, equal and inclusive societies based on the rule of law.

Purpose: Preventing and combating all forms of gender-based and sexual violence


Where: Bosnia and Herzegovina, Croatia, Cyprus, France, Greece, Italy

Specificity: Strengthening small and medium-sized organizations, for a duration of 2 years

Total amount to be granted: EUR 750,000

Maximum amount/organization/2 years: EUR 60,000





Non-profit organizations registered in one of the countries targeted by the call.

Organizations must be run by a majority of women.

Commitment to women's rights and/or to women's and/or feminist movements.

Projects must be focused on preventing and/or tackling gender-based violence.

Respect of EU values: Human dignity, freedom, democracy, equality, rule of law, human rights.







PRIORITY CRITERIA

- Limited or no access to bilateral funding of traditional EU funding streams.
- Small organizations with annual budgets under EUR 50,000.
- Less than 5 years of existence.
- Grassroots organizations working at local level.
- Work on gender-based violence and the intersection between gender and other forms of discrimination.
- Led by marginalized women, such as rural women, migrant women, LGBTIQ+ community, young women, racialized women or women with disabilities.
- Have ethical and safety protocols or measures to ensure the well-being of women victims/survivors of violence.








- Activities on preventing and combating gender-based violence with an intersectional perspective.
- Provision of direct support to women and LGTBIQ+ people suffering gender-based violence, such as legal assessment, psychological support, group support, collective care activities, helplines, counselling, women's shelters, etc.
- Coalitions and partnerships among organizations.
- Lobbying/advocacy to influence policy and decision-making processes.





- o Research aimed at analyzing strategies to prevent and respond to gender-based violence.
- Awareness-raising and communications/information activities aimed in particular at creating links and leading communities.
- Tackling gender stereotypes as root causes of gender-based violence, including through the engagement of men and boys.
- o Training programs providing for the protection of victims/survivors, professional trainings, etc.





IMPLEMENTATION PERIOD

Selected projects must be implemented between July 15, 2024 and July 14, 2026

(Minimum 20 months, maximum 24 months.)





Maximum grant size: EUR 60,000 / 2 years

Minimum grant size: EUR 5,000 / year

Minimal budget of the organisation: EUR 5,000

Co-funding: It is not necessary.

Funds will be allocated in two instalments: 50% of the total amount will be paid after signature of the contract. The remaining 50% will be paid after approval of the interim report.

Total amount to be awarded for this call: EUR 750,000



SELECTION PROCESS

Proposals will be reviewed by a committee made up of members of the MedWF team, which will review the proposals based on the criteria established in this call, according to the following scale:

- 25 points: GBV experience, approach, reliability, work with other networks or organizations
- 35 points for the quality of the proposal, taking into account criteria such as clarity, coherence and feasibility, or budget consistency
- 40 points for the priority criteria described in this call.

Results will be shared with applying organizations.

Organizations may request additional information on the evaluation of their proposals.



IMPORTANT REMINDER

Proposal reviewing, selection and appeal mechanism: May 2 – June 15, 2024

Agreement signature with with grantee-partners: June 16– September 20, 2024

Projects duration: July 15, 2024 – July 15, 2026

The MedWF and the EU logos will have to be used on the communications material of the funded projects (websites, etc.)
