Executive Director of the MedWF

We could describe 2022 as an exceptionally dynamic year, as it demanded an enormous amount of energy to tackle the countless challenges that arose.

First, within our organization: several major changes took place in the team, each requiring a quick rebound and often reorganization. **Departures (1), arrivals (2), maternity leave (1) and medical leave (2)** prompted us to transform the job of Association Relations Officer, whose scope had grown considerably (in 2022, there were 30 more initiatives than the previous year), into a three-person Association Department, and to continually adapt our activities to the capacity of a team that varied in terms of number and experience.

When we add to this the **preparation of our Strategic Plan**, which began in April and involved numerous meetings, and the implementation of our pilot program "**Taking care of ourselves and others**", we have been kept constantly on our toes in terms of reflection, adaptation and action.

And this held true for all of our activities. We started the year at the somewhat slow and individualistic tempo adopted during the Covid years, but as the months went by, we gradually picked up the pace of our collective activities. This culminated in the last quarter with a range of meetings and training courses relating both to our own activities and to those of the various networks we belong to, which were coming back to life after a two-year hiatus.

As part of our program to strengthen the women's movement, we organized approximately 15 meetings, training sessions and support workshops for women's associations in various countries, either face-to-face or via videoconferencing. At the same time, our advocacy and fund-raising activities meant that we had to take part in around 50 meetings – again both face-to-face and by videoconferencing - organized by various close and institutional donors.

Seeing again or meeting for the first time the associations we support, finally stepping away from our screens to talk face-to-face, taking the time behind the scenes to engage in the informal discussions that are so rich and impossible to achieve virtually, was fundamentally reinvigorating.

All of these "face-to-face" encounters were particularly important given that half of our team had never had the opportunity to meet the associations and/or other foundations with which we work. This enabled them to appreciate the scope of our work, which would have been impossible to do in an office behind a computer, and to create more personal links with people with whom they had previously corresponded by e-mail.

And among all these gatherings, we had the great joy and honor of bringing together in Paris, for the first time in five years, our advisors from the 21 countries bordering the Mediterranean to help us define the strategies we should pursue. Like all of the feminist activists whom we met during the year, our advisors identified as a priority the systematic strengthening of women's movements, the key line of defence of women's rights, which are under attack from all sides....

I. Strengthening the women's movement

A. Support for associations

Across the Mediterranean, women's associations face numerous challenges in their individual contexts, including the rise of fundamentalism and masculinism, state repression and/or the withdrawal of support from donors that are redirecting funds to Ukraine. Added to this are a lack of resources and work overload, all of which continued to affect associations in 2022, with, in some countries, immense difficulties posed by economic and political crises.

1. Financial support

Grant amounts

In 2022, MWF supported:

The grant amounts ranged from €1,000 for one-off emergency support to €22,000 for shelters for women victims of violence and, most often, for women's associations in low-income neighbourhoods.

In 2022, 6% of the initiatives supported provided emergency assistance to associations struggling to finance their operating costs.

An increase in the size of the grants, which began in 2021, continued in 2022; we awarded 35 grants above the average amount, which is now €6,934, compared with €5,378 in 2021, with the median amount still €5,000.



• Breakdown of the grants in the region


We strive to distribute grants as evenly as possible so that associations in every Mediterranean country may benefit from them. The number of requests varies from one country to another; the distribution of grants is therefore proportional to the demand, especially as we refuse few requests.

The particularly large share in France this year is due to our continued facilitation of a network of associations in lower-income neighbourhoods of Ile-de-France (Sevran, La Courneuve, Saint-Denis, Gennevilliers) and special support from our donors devoted to this purpose.

The significant share of regional associations is also due to support for the development of the Medfeminiswiya network.



PERCENTAGE OF AMOUNT OF GRANTS ALLOCATED BY COUNTRY




Use of grants by the associations

More and more associations are asking us directly for support for their operating costs (45% of grants). We are very committed to offering this possibility; it enables associations to become stronger and collectives to climb out of precarious situations so that they can carry out their actions successfully.


We also support individual feminist activists, either so that they can participate in important women's rights events such as the UN Commission on the Status of Women in New York, or to encourage them in their work.

In 2021, we began setting up "mobilizers' fellowships", created to thank and encourage feminist activists who work tirelessly to mobilize women for equality and social change. We continued the program in 2022. This grant comes with no strings attached and is intended to help these activists not only to continue their work, but above all to look after themselves.



Most often, our support goes to associations that defend abused, marginalized (precarious, living in remote areas, cut off from institutional systems), migrant and refugee women. Most of the initiatives supported are aimed at all women, whatever their age, economic and social status, disability, or sexual orientation. We also do our utmost to support associations that focus specifically on lesbian, bi and transgender women, who are often overlooked by donors. We have not yet received many requests from associations working with women with disabilities, of which there are, depending on the country, few in number.

CATEGORIES OF POPULATION SUPPORTED BY THE ASSOCIATIONS IN PERCENTAGE









The associations' most common fields of action are combating violence against women, defending sexual and reproductive rights, migration and political participation.





The most support is given to associations offering services such as shelter for women who are victims of violence. Awareness-raising and advocacy are also key strategies used by associations to advance women's rights in their countries.


STRATEGIES IMPLEMENTED

2. Specific support for networks: the case of Medfeminiswya - a network of Mediterranean feminist journalists

Supporting networks formed by women's associations and individuals committed to women's rights is one of our priorities.

The Medfeminiswya network was established with help from the MedWF in 2018 by journalists based in Algeria, Croatia, Egypt, Spain, France, Italy, Lebanon, Libya, Malta, Morocco, Montenegro, Palestine, Tunisia, and Turkey. We believe that it plays a vital role through its production of high-quality articles and reports, in written, audio and video formats, on a wide range of current events covered from a feminist perspective. This platform meets an enormous need for discussion and information on women and the context in which they live based on verified, balanced information, free from misogynistic or racist stereotypes, and far from fake news and hate speech.

In 2022, the MedWF's contribution to the development of the Medfeminiswya network and its platform was again substantial.

We provided financial support for the operation of the platform from January 2022 to November 2022, meaning for the editorial team (two editors-in-chief, a web editor and a program coordinator), journalists, translators and interpreters for the organization of videoconferences, and we put them in touch with other donors so that the Medfeminiswya network can diversify its sources of financial support.

3. Support beyond grants

When the grant selection committee is interested in a project but the MWF cannot finance it, or can only do so in part, we try to provide the association with the addresses of other donors that might finance them. The MedWF also on occasion introduces associations to donors. This often involves local businesses, but also private foundations and feminist funds. Donors are increasingly recognizing the MedWF's expertise, and are now contacting the Fund to find associations to support financially.

This year, we presented about ten associations to our partner donors, and were also asked several times by our colleagues at feminist funds to provide an opinion about a local association. We recommended five, all of which were supported.

Finally, MedWF supports newly-created associations with little experience or facing various difficulties:

- -by helping them set up their structure and activities, and formulate their projects for other donors;
- -by reinforcing a relationship of transparency and fluid communication, and by adjusting our practices to better understand them and their needs in the field, in particular through on-site visits and videoconferences.
- -increasingly, we are being asked by associations we support to help them rethink their own organization and resolve situations that are holding them back in their work.

This year, we organized a series of small working sessions, in our Paris offices, by Zoom or locally, with seven associations from France, Algeria and Morocco, for individual or group coaching on a variety of issues, such as managing relationships within the association, preventing burnout, fundraising strategies and financial resilience, networking, and so on.

4. On-site visits

Since travel and face-to-face meetings became possible once again, we visited numerous women's associations. These visits are an opportunity for team members to gain a deeper understanding of the work carried out by the associations supported and the conditions under which this work is done, as well as to strengthen links that often have been formed only virtually.



Morocco

From 17 to 21 October 2022, we travelled to Morocco to carry out a field visit with the invaluable help of our partner, the Ytto Foundation. This mission took the form of a visit to six associations supported by the MWF, some of which have been active for several years, located in rural and urban areas.

In addition to strengthening our links with these associations, this field visit enabled us to rework our strategy in Morocco, take stock of the current reality on the ground for feminists and feminist associations in Morocco, and meet new associations that could become new partners.



Algeria

Several site visits took place during 2022, on the occasion of Feminist School sessions and other women's movement gatherings, such as the one in Mostaghanem that brought together the Algerian women's movement in September. On each occasion, the MWF team took time to visit the associations on their premises and assess the difficulties they face and their needs.

France

Several site visits took place during 2022, often on the occasion of events organized by the associations. We attended several events organized by Maison des Femmes de Paris, Stop Fisha, Excision Parlons-En and Africa 93.

We also organized online meetings with seven new associations, five of which we now support.

Finally, several associations visited us in our offices and we organized an event in Paris to mark the release of Stop Fisha's book.



B. Organization of meetings, forums for discussion and strategic reflection

Prompted by the observation that associations working for women's rights are swamped with work and are rarely able to meet each other outside emergencies, over the past few years we have organized strategic reflection meetings bringing together associations from the same country or from around the Mediterranean basin. Since 2011, we have organized meetings of this kind in Egypt, Algeria, Tunisia, Croatia, and France, and in Tunisia for representatives of Libyan associations, and in Italy, Morocco and Tunisia for Medfeminiswya. The widespread use of videoconferencing tools since the COVID-19 crisis has enabled us to increase the number of these meetings, particularly in the North Africa and Middle East sub-regions.

The participants discuss the major issues facing them in relation to their association, daily work, and the situation of women in their context, and manage to reach an agreement on which should be addressed in priority. Together, they assess what they believe to be their strengths, weaknesses and the allies on whom they can rely. This assessment enables them to refine collective strategies on which they can agree at the end of the meeting.

Each time, our role consists of organizing the logistics of the meeting and facilitating the discussion by establishing a welcoming atmosphere, ensuring everyone has an equal amount of time on the floor to speak, and providing an accurate account of what was said. The lack of an obligation to achieve results and the presence of a third party such as MedWF makes it possible to change habits of communication that were forged out of emergencies and existing local power relations, habits that often hinder the definition of a long-term strategy.

Throughout the year, we organized online meetings: between associations from the Middle East region, between North African associations, between Libyan associations, between Palestinian associations, between Lebanese associations and between Egyptian associations interested in ecofeminism, around COP27, and between associations from working-class neighbourhoods around Paris.

In addition, with the end of COVID-related restrictions, we were able to organize several face-to-face meetings in France and Tunisia. And finally, for the first time since 2017, we have been able to bring together all of our Mediterranean advisors in Paris for two days.

1. Meetings with women' associations in lower-income neighbourhoods

The 14 women's associations from lower-income neighbourhoods who took part in the meetings organized by the MedWF and CPossible in 2020 and 2021 expressed the need to work together and affirmed their desire to consolidate the nascent network.

In 2022, three online meetings and one face-to-face meeting were organized. They were to:

- · Bring associations together to identify with each other;
- Pick up on the proposals made during the interviews conducted at the end of 2021 and develop them further;
- · Reinforce relationships between network members;
- Strengthen the network's capacity to understand racism through a workshop entitled "Noir.e, une couleur comme les autres?" (Black, a color like any other?), organized by Citoyenneté Possible.

In July 2022, the MedWF organized a friendly get-together on a French riverboat (called "bateau-mouche") where we all enjoyed a meal. For some, the cruise was the first opportunity to meet face to face after two years of Zoom meetings.

The network's activity, still dependent on the coordination provided by the MedWF, was less intense in 2022 than in 2021 due to various changes within our team.

2. Advisors meet in Paris

In September, we were finally able to gather in Paris all of our advisors to help us define our strategies for the future. They came from 20 Mediterranean countries: Albania, Algeria, Bosnia-Herzegovina, Croatia, Cyprus, Egypt, France, Greece, Italy, Israel/Palestine, Lebanon, Libya, Malta, Montenegro, Morocco, Spain, Tunisia, Turkey and Syria.

These two days were an opportunity to catch up with those with whom we have been working for a long time, and to get to know those who have joined our network more recently. Each presented her own context, from which several common points emerged, both internal to the women's movement (such as divergences, prioritization of the issue of violence, expansion into rural areas, weakening and instrumentalisation of the movement) and relative to the situation of women (low political participation, the issue of migrant women, laws not applied or being rolled back, safety of activists).

Four themes were selected for further reflection: safety, the need for unconditional sisterhood, the promotion and dissemination of the feminist culture and a women's court. Several recommendations were made:

- set up a working group focussing on a charter of Mediterranean feminist values and establish common ground;
- · create a working group focussing on the women's court;
- · build strong groups of young feminists;
- lobby for flexible, non-competitive, unrestricted funding that encourages the creation of alliances and enables us to define our priorities;
- create forums for dialogue, exchanging best practices and defining priorities.

The meeting was also an opportunity for us to ask them how they understood their role as advisors, what they expected of us and what we could expect of them.

Although we were all somewhat demoralized by the presentation of the contexts, we left happy and motivated by the vibrancy of the collective discussions and the determination to take action.

3. Brainstorming workshop in Algiers

On September 22, we organized a workshop in Algiers on the topic, "Overcoming the difficulties encountered by women's associations, particularly in acquiring funding".

The workshop, which brought together 11 women's associations from Algiers, Oran, Tizi Ouzou, Timimoun and Blida, addressed a number of issues:

- · learning how others overcome difficulties;
- exploring personal experiences of professional and/or activist difficulties, as the two are often closely linked;
- gaining a clearer vision of the women's movement as a whole, strengthening their network to work collectively and intergenerationally, and more specifically, finding solutions and tools to overcome difficulties encountered collectively;
- · protecting themselves and ensuring the association's security;
- pulling the association out of a survival situation.



4. Strategic planning meeting in Tunis

On 25 and 26 November 2022, the Mediterranean Women's Fund organized a strategic planning meeting in Tunis. The meeting brought together 17 participants representing 14 associations of the Tunisian women's movement. The group met for two days of discussions about the situation of the movement and the strategies that they should collectively implement to strengthen it.

The discussions highlighted the main contextual factors:

- the instability of the political context and backsliding on the electoral law remain a permanent threat to the movement;
- the situation of women is increasingly precarious (rolling back laws, in particular the right to abortion and the right to reproductive and sexual health), and violence against women is increasing and becoming commonplace;
- women's associations lack the financial and material resources to fight this backlash, and are facing the splintering and weakening of the women's movement.



While strengthening the women's movement, safeguarding existing gains remains a priority.

Three areas of work were identified at the end of the meeting:

- working to bring the movement together (creating a charter of shared values and federating the group through meetings),
- training feminists and associations to protect themselves (digital security in particular),
- and strengthening an observatory on violence against women.

5. Meeting of North African associations in Tunis

As part of the "Féministe en Action" project, a meeting was held in Tunis to set up a network of North African associations on 27, 28 and 29 November 2022. It brought together 17 people from 13 different associations in five North African countries: three associations from Morocco, three from Algeria, three from Tunisia, three from Libya and one from Egypt (two other individuals were not granted visas).

This meeting enabled us to identify the general contexts of each country and to collectively establish priorities that make up four areas of work:

- **The Network:** launch the creation of a feminist network with membership to be determined, which would work on the three areas at the same time: safety, succession, court.
- **Security for activists:** security is a priority for activists, especially in violent contexts; when it is assured, young people can be encouraged to join the movement. Security will be the framework within which the network is strengthened, ensuring its continuity.
- **Succession**: passing the baton to the next generation of activists must be considered from the very start of the network, for example by setting up a network steering committee consisting of 1/3 old-timers, 1/3 middle-aged people and 1/3 young people. The network must embrace young people and adapt to the context of each country.
- **The Court:** A committee must be established to monitor the work of the Mediterranean Tribunal, which could provide a framework for work on security.
- **The Charter**: several charters need to be drawn up. In order of priority, they are a security charter tailored to each country context, a succession charter, and a network values charter to ensure the network's long-term future. Each charter must be presented to the group.







6. Online meetings

· Strategic planning meeting with women's associations in Libya on May 10

The meeting brought together 30 feminists representing associations, large and small, from all regions, cities and rural areas.

The context is very difficult for women in Libya, and the political instability that has reigned since 2011 has led to a backward slide across the board, including in constitutional measures, a return of traditional customs and an increase in violence against women, which remains unpunished.

Priorities and recommendations include:

- 1. Support and participation of women in the field of politics, especially women in rural areas;
- 2. Psychological support and raising awareness about women's rights;
- 3. Inclusion of young people in public life and reduction of armed violence;
- 4. Implementation of the Climate Agreement (drought, desertification, urban sprawl);
- 5. Ensure the involvement of women at more senior levels, such as decision-making positions;
- 6. Reduce gender and sexual violence and raise awareness about violence against politically active women;
- 7. Provision of safe spaces for women and young women;
- 8. Legal awareness and literacy training for women;
- 9. Reduce violence:
- 10. Boost women's skills and capabilities;
- 11. Create a network to facilitate communication and collaboration;
- 12. Right of Libyan women to pass on their nationality through marriage to a non-Libyan.
- Strategic planning meeting with women's associations in the Middle East, June 14

The meeting was attended by 18 people representing five Egyptian associations, one Turkish association, five Palestinian associations and four Lebanese associations.

Numerous common points emerged regarding the struggles waged by the associations:

- combating violence against women;
- the safety of women victims of violence and activists;
- advocacy to get laws passed and enforced.

Participants reported great difficulty in accessing funding to enable them to sustain their structures' operations and growing threats to the movement (rolling back of rights, increase in violence, etc.).

The collective priorities identified by the associations were legal training to assert their rights, networking and the safety of activists. And lastly the need to define a unified feminist agenda in the region, with knowledge and skills shared between the region's associations.



Strategic planning meeting with North African women's associations, October 6

The meeting was attended by 19 people representing three Algerian associations, four Egyptian associations, one Libyan association, five Moroccan associations and three Tunisian associations.

Across the region, associations are witnessing a resurgence of ultra-conservatives in both social and political spheres/places of power (concept of shame, constitutional change, etc.). They also reported an increase in violence against women; the various crises have reinforced gender-based violence, and the general security situation is affecting feminist movements. Mirroring a deteriorating security situation across the country, the insecurity of feminist activists and associations is increasing proportionately.

The main common needs identified were the need to reinforce the security of activists and feminist associations, and to increase funding to ensure the survival of structures.

The need to bring the movement together by combating the distance between rural and urban associations also was emphasized.

Three proposals for joint strategies emerged from the meeting:

- 1.to produce and publish a report on the seriousness of violence against women throughout North Africa and the Middle East as a means to globalize the struggle;
- 2.to speak with one voice to wield more clout in the face of conservative discourse and to work on an alert/solidarity system between activists throughout the region;
- 3. and finally, to create a statute for women's rights defenders to improve their security and the conditions of activist life.
- Meeting on the involvement of Egyptian feminist associations in Cop27 on July 21 This meeting, which brought together seven associations, essentially enabled us to discover whether environmental issues were being addressed by the associations, and to identify those for which this was a priority.

After a rich discussion and exchanges between the participants on the situation in the region and the actions underway in the context of COP27, which was taking place in Sharm El Sheikh, several concrete ideas and plans were put in place. Taking the view that Egypt is an influential country in the region able to play a role in promoting and raising awareness of eco-feminism, and on the basis of the funds available for the development of this area of activity, the various associations stressed the importance of networking to create a coalition that could participate in COP27, either formally through an already-registered entity, or informally.

A great deal of importance was attached to gathering information and conducting precise studies to raise awareness and facilitate joint work at the regional level.

C. The Feminist Training in Collective Intelligence programs

The Feminist Training in Collective Intelligence (FTCI) program was inspired by personal experiences in the feminist movement and a widely shared observation, namely that associations, made up of very courageous, dynamic women with a wealth of skills, are not working to the best of their abilities, either internally or with each other, and we can identify major areas of energy loss at both psychological and organizational levels.

- At the individual psychological level: poor self-knowledge, poor self-esteem, lack of self-confidence, lack of empathy for one's body and its needs.
- At the organizational level: lack of listening skills in debates, difficulty in letting go of control
 for leaders, difficulty in positioning oneself in front of an authority figure, inability to manage
 conflicts in a non-violent way, lack of sharing of past experiences, lack of method in building
 a project, poor communication skills.
- At the broader level of networks of organizations: the same types of weaknesses as for organizations, with in addition a lack of openness towards others, a sense of being fundamentally threatened by other organizations, difficulty in assuming own political power.





This training thus aims to strengthen activists, organisations, and thereby the women's movement, by providing a space for committed women. This space is designed as a space of freedom where they can take time for themselves (as much as individuals as groups), get to know themselves and meet others, learn and discuss, strengthen themselves personally and reinforce each other, and form ties that will help them further their cause.

For the first time since the COVID-19 crisis, we were able to organize a face-to-face FTCI session in Morocco. In addition, our trainers helped design and participate throughout the year in the Feminist School created in Algiers by one of the participants in our 2018 training of trainers.

Finally, in addition to training modules on self-esteem implemented by our partner Citoyenneté Possible, part of our project with associations in low-income neighbourhoods, we have provided several associations in France and Algeria with ad hoc training on a collective intelligence tool, in particular the inner weather and the relational charter.

1. The Feminist Training in Collective Intelligence in Morocco

As we were not sure whether we would be able to hold other sessions under the AFD project, we organized a hybrid session of the Feminist Training in Collective Intelligence, combining elements from the three sessions to work on self-esteem, relationships with others and with one's group, and collective intelligence between various groups. It brought together 21 young women between the ages of 21 to 41 from 7 towns and 11 associations, and was held in Marrakech, the city most accessible for the majority of the participants.

These three days of training lead to the identification and naming of societal constructs and mechanisms of oppression against women through hands-on experimentation. It is only through this kind of initiation - starting from one's own experience, becoming aware through one's own body, one's own path, one's own conditioning and self-censorship - that young women manage to name and conceptualize.

For us, the emotional, sensory and bodily approach takes precedence over the intellectual approach - and not the other way round – during the training.

Without a doubt, our participants' social and geographical diversity reinforced the validity of our choice of approach: on the one hand, the young rural women, sometimes Berber-speaking, farmers and weavers, city dwellers, graduates and/or unemployed... reinforce our belief that feminism must be felt in order to be better thought out; on the other hand, as we firmly defend the principle that "no one should be left by the roadside", the question of semantics must not create inequalities between participants. Feminist concepts are therefore mentioned at the end of the days, when they can be integrated more easily. Like "giving in is not consenting", which was definitely understood.



2. Follow-up of trainings

The FTCI programs aim to strengthen the women's movement by convincing the young women participating in them that they are strong and are part of a greater whole, locally and regionally.

Since we started the FTIC program in 2013, we have systematically implemented a post-training follow-up that includes:

- **Information**: we regularly send all participants information that we think will be of interest to them: on women's rights or calls for projects launched by international donors, invitations from women's organizations, young people or institutions to take part in regional or international meetings, or human rights training courses.
- Connecting: whether in response to needs expressed by the young women trained or at the
 request of donors, journalists, or other organizations, the MWF seeks to facilitate as much
 as possible the young women's access to the outside world. Over the year, THE MWF thus
 frequently helped the young women participate in events/actions organized by
 associations.
- **Referrals**: on a regular basis, at their request, the MedWF recommends young female jobseekers to institutions or associations.
- Accompaniment: we see our back-up support as another form of training. This involves supporting a young woman individually as she reflects on issues, writes a thesis and develops her plans, as well as inviting young women to attend local meetings with us so that they learn about the collective dimension in the security of our company. Lastly, we help them consider the kind of organization they wish to set up, as we have done this year in France, Morocco and Tunisia.

II. Communication and Fundraising

A. Communicate what we do as effectively as possible

The production of videos and articles, the organization of events and conferences, the maintenance of our social network presence, and participation in meetings all involve considerable effort on the part of our salaried team and Board of Directors. However, these activities are crucial to convincingly explain the importance of supporting women's fight for their rights and women's networks in the Mediterranean region.

This year, we have continued to focus on our communications, thanks to our part-time communications officer, who has worked on updating our new website, managing our social networks, developing communications strategies for the "Rencontres du Fonds pour les Femmes en Méditerranée", highlighting our associations, our fundraising letter, and so on. The challenge lies in paying special attention to our communications efforts while keeping in mind that they are a means and not an end, and that we must take care not to let ourselves lose focus on our priorities. This means constantly weighing up the investment of time and money required, on the one hand, against the results of this communication in building our support network and fundraising, on the other.

1. Website, biannual letter

This year, the Mediterranean Women's Fund website has undergone several organizational and design changes to better meet the needs of our visitors:

- "Associations": initiatives supported by MedWF are now grouped together on their association's page. This makes it possible to see how long an association has been supported by MedWF, as well as the diverse range of projects supported (operating costs, events, awareness-raising, etc.). This new display aims to give a clearer picture of our mission as a feminist fund: to provide sustainable, flexible funding tailored to the real needs of associations.
- "News": our various news categories ("our publications", "our resources", "our events") are now grouped together on a single page, to facilitate access to MedWF news.
- "Home": we decided to introduce a pop-up carousel on MedWF's home page, enabling our visitors to quickly access a selection of pages representing our latest news (new projects, upcoming events, articles written by our team, etc.).

These changes have considerably increased the number of pages visited on our website (an increase of 52% compared to 2021). We hope to continue on this path in 2023, in order to offer our visitors increasingly high-quality, easy-to-access content.

The associations pages visited are more diverse than in previous years, which coincides with our communication strategy on our social networks and in our biannual newsletter.

The biannual newsletter

The biannual letter appears in French and English on the website and in a paper version. In 2022, MedWF published two newsletters and one appeal for donations (which were sent to over 3,000 individuals and associations in French and around 600 in English). With an opening rate of over 40%, the twice-yearly newsletter seems to be finding its readers. All letters can be downloaded from our website, on the "Our resources" page. A few hundred copies of the paper version are printed and distributed at events and meetings, enabling us to establish a link with future grantees and donors.

2. Social networks

Facebook

On our Facebook page, we share our activities, showcase the work of the associations that we support, and inform our subscribers about news of women's rights in the Mediterranean. Women account for 80% of our subscribers. Our Facebook page is read mainly in France (40%) and the French-speaking countries of the Maghreb (Tunisia (11%), Algeria (8%), Morocco (4.8%)), but also in Italy, Egypt, Spain, Lebanon and even beyond the Mediterranean, in the United States and Belgium. This diversity is encouraging us to diversify our content to adapt it as much as possible to non-French-speaking audiences, and poses a real translation challenge.

Our Facebook page following grew slightly in 2022, reaching 4,606 "likes", an increase of 7%.

Twitter and Instagram

Less active on Twitter this year, our account saw a slight decrease in the number of followers, from 1,071 in 2021 to 891 in 2022, a drop of 17%. This decreased activity is linked to the end of our #StopTalkingStartFunding campaign under the Génération Egalité Forum.

Launched in 2020 to reach a more image and video-oriented audience, our Instagram account is gradually growing and we have reached 926 subscribers, an increase of 38%.

LinkedIn

Since 2021, we have maintained our presence on the LinkedIn professional network, where we have 1,362 followers, an increase of 76% compared with 2021. We post our various activities on the site, including job offers when we have them. We are also regularly mentioned by partners, which helps to increase our visibility.

3. Constitution of video document archives

This systematic documentation serves three purposes:

- 1. The first is the most obvious: to demonstrate through short three to six-minute films what we do, with whom we work and what the people receiving our support think of our work. This provides us a brief assessment although we have no illusions about the bias introduced in an interview conducted by a donor but above all it brings to life what we try to communicate as it is difficult to understand the profundity of actions and human feelings through a simple description. Since we started showing the short videos, our target audience better understands our work and feels much more involved.
- 2. The second purpose is to enable us to improve and better think about our own work. By visualizing our activities, and listening again to the interviews, we can better assess our methods, propose new ideas for strategies to implement, and, as we wish to make models of our trainings, this material will help us turn action into theory.
- 3. Lastly, the third purpose of this documentation is to constitute archives for researchers and particularly the women's movement in the region (for example, strategy meetings are filmed in their entirety and copies are given to the women's associations involved).

In 2022, a series of video reports, interviews and photos were produced:

4. Organization of events

Meetings with the Friends of the Fund

In Paris and Montpellier, we regularly organize meetings to which we invite those we call "Friends of the Fund" (supporters, volunteers, donors, associations, young women trainees, etc.) to present the components of our work, the training programs and the strategic planning meetings, and to inform them of progress in fundraising. These meetings are an occasion to exchange opinions and ideas that nourish the team's own reflections, and are essential. They help on one hand to strengthen ties with our growing number of supporters, and, on the other, to allow them to become more involved in our activities.

In Montpellier, where the Friends of the Fund have formed a collective, we met in December to exchange news about the MedWF and future activities planned. The possibility of co-constructing an event with the MedWF and associations, including some of the Friends of the Fund, around 8 March 2023 was raised.

In Paris, we organized an aperitif meeting on March 22. It was an opportunity to bring together the Friends of the Fund in Paris, partner associations and feminist activists to recreate non-virtual links.

Meetings between donors and associations

We innovated this year, taking advantage of digital tools to organize meetings between donors and associations, with a view to forging links between activists on both sides of the Mediterranean. By inviting our partner associations to come and present themselves and exchange ideas, these meetings enable us to strengthen our ties and make them better known to our donors. These meetings are designed to be participative, and after the associations have described the context in which they operate and their many battles, the public is invited to ask questions.

For the first meeting, "Women in social space, from real to virtual", on June 14, we invited the associations Féministes contre le cyberharcèlement (France) and The Sex TalkArabic (ANMO region), who came to talk to us about the gendered experience of physical and digital social space. They shared their testimonies and expertise on the fight against aggression, which now takes place not only in physical space, but also in virtual space. Due to the tenuous legal framework and the lack of judicial resources, these attacks (harassment, defamation, identity theft, sharing of intimate photos) are very rarely punished, and their impunity encourages their spread.

The second meeting, "Feminicides on the South Shore, a silent epidemic", took place on October 11 in the presence of the associations Féminicides Algérie (Algeria) and Aliaa Awada, MENA Women Strike (Syria) and feminist media outlet No2ta (Lebanon). They took stock of feminicides in the ANMO region (patriarchal culture, non-enforcement of laws, status of women, taboos, etc.) and explained what they believe to be the solutions to the silent epidemic of feminicide in the region, such as changing mores, educating children, raising awareness and training police, making these crimes visible and fighting impunity.

5. Public appearances and participation in meetings

To make our work known and lobby for the rights of women and the financial support needed for their defence, members of our Board of Directors and our salaried team take part in public meetings, radio and TV shows, and online and printed newspapers whenever the occasion arises.

On another front, MedWF members also actively participate in local, regional and international meetings because this enables us to better understand associations and the challenges faced within different contexts.

In addition, several MedWF members took part in webinars and virtual or face-to-face roundtables:

- On March 7, Nadia Aïssaoui gave a talk on the theme of popular ecology during a webinar to mark the launch of the action-research project "Polyphonie écoféministe: entre terre et mè.re.s";
- On April 27, Caroline Brac de la Perrière spoke at Ariadne's meeting in Lille about mistakes made as a donor;
- On May 31 and June 1, Nadia Aïssaoui took part in and spoke at an online training course on ecofeminism, where she presented MWF;
- On May 28, Nadia Aïssaoui led two workshops: "popular ecology" and "self-care", as part of the Festival Polyphonies Écoféministes in Belgium, organized by the association Le Monde Selon les Femmes:
- On July 4, Julia Schweitzer spoke at a meeting of the Cercle Action Internationale organized by the Centre Français des Fonds et Fondations (CFF), to present the initiative to create a gender coalition within the CFF;
- On October 27, Caroline Brac de la Perrière attended and spoke at the European Commission's Consultation on the Directive on violence against women and domestic violence.





B. Fundraising

1. Fundraising in France

For several years now, we have ensured that over a third of the funds that we collect comes from fundraising in France. After a serious drop due to the particular context of the COVID-19 crisis, the share of our local resources has greatly increased, rising to 44%, and has diversified to include individual donations, private foundations, corporate foundations, local authorities, the French embassy and the French Development Agency (AFD).

Local governments and other French government bodies

As we are headquartered in France and are subject to French law, we continue to pursue our efforts to establish partnerships with various local and regional government structures, notably the Occitanie region.

The "Feminists in Action" project, financed by the French Development Agency (AFD) through its Fonds de Soutien aux Organisations Féministes (FSOF), and implemented by the consortium comprising Care France, Equipop, Oxfam, and the feminist funds IPBF, XOESE and the Mediterranean Women's Fund, is continuing. Implementation of actions began in 2022; ten associations were supported and several meetings and training sessions were organized in the North Africa-Middle East region.

Private foundations

There remain too few people in France interested in the issue of women's rights. We therefore try to collaborate with those who work in this field, within the French foundations centre.

This year, we were again able to count on the help of some of them, which already were convinced of the merits of our mission, for our general operations and for projects like the collective intelligence training program. They also demonstrated their flexibility at a time of crisis like the one the world is going through by allowing us to use their grants for what we feel is important when we cannot implement our planned activities, and we are grateful to them for this.

Individual donators

Our goal is to weave a net of solidarity - a tangible movement – in which everyone can feel that they have a stake. Not everyone is able or willing to get involved in the struggle on a daily basis, but many are convinced that without the grassroots work of feminist associations, the status of women would not have evolved. Donating is then a way to be part of the movement, of showing solidarity with the associations' actions.



Throughout the year we encourage people to make individual donations through, among other means, fundraising letters.

- This year, we sent out an appeal for donations in December, by regular mail to 700 donors and by e-mail to 3,000 people.
- Since 2018, MedWF has been listed on Lilo, a search engine that turns the searches of people who use it into drops. The drops are paid to a project listed on Lilo, in general social and environmental projects, according to the wishes of the internet user. The MedWF project listed is named, "Training young women leaders". Once a certain number of drops have been given, the drops are transformed into money; our friends' searches and their donation of the drops generated raised just over €443 this year. We have noticed a slackening of motivation among our supporters to use this platform, which is no doubt due to the fact that we have not issued a new call to do so. (https://www.lilo.org/fr/#)

2. Raising funds outside France

Private foundations and feminist funds

This support is the most important for the MedWF. The multi-annual support from the Sigrid Rausing Trust and the Oak Foundation, as well as regular support from the Global Fund for Women - which enables us to use their funding for our operations - have dramatically changed our outlook on the future and enabled us to be more ambitious. Thanks to several multiannual unrestricted grants, we could continue to expand our team and confidently conduct our activities in 2022.

This year, some of our newest donors have renewed their support for specific projects, such as Foundation for a Just Society, for our "Knocking on EU doors" work, undertaken with European feminist funds, and Calleva Trustees for a multi-year grant to certain associations. We also received new funding from Open Society Foundations for our major project on sexist and racist discrimination in lower-income neighbourhoods, and for the "On the Right Track" project, run with European and Latin American feminist funds. Finally, we received support from Mama Cash's Solidarity Fund for our study of feminist management and our managerial transition. Last but not least, new backers have come on board, such as Fenomenal Fund, which has supported our operations.

Public funds

This year, we developed a project with the support of the European Union, Erasmus +, in partnership with the Spanish fund Calala, for a project entitled "Achieving gender equality through the feminist fund model: empowering grassroots women's organizations".

III. Strengthening the Mediterranean Women's Fund

A. A. Strengthening alliances

Since it was created, the MedWF has worked with other donors that have the same or similar mandates as ours to ensure the greatest amount of support for women's associations in the region.

1.Collaboration with Prospera, International Network of Women's Funds

The MedWF is part of Prospera, an international network of feminist funds, comprising 44 funds from around the world, all with a mission similar to that of the MWF.As it has every year, the MedWF developed several collaborative projects with this network and its members.

In particular, we were heavily involved in the long and intensive process of drawing up the network's new strategic plan, Noor, for the next ten years. One of our members was a member of the Noor steering committee, as well as being active in the values working group, and two others participated in the governance and vision groups. In addition to numerous online meetings, we travelled to Mexico twice for face-to-face meetings - the network's first since 2019!

Collaboration by exchanging experience, tools and know-how

Numerous meetings are organized over the year by the network or members of the network. They are occasions to learn, for example, new assessment methods, think about new fundraising strategies, and analyse the situation of women in different regions.

This year, it was through the Erasmus+ project that the European funds were able to share their best practices and the tools they have put in place to better support associations, and together develop a document on their know-how: "Achieving gender equality through feminist financing: the women's fund model". This document presents the feminist funding model, with examples accompanying the principles set out by the 13 feminist funds in the European chapter of the Prospera network, as well as recommendations for public and private funders to improve their ability to support women's associations.

Financial cooperation

As often as possible, MedWF establishes agreements with other feminist funds to support women's associations more efficiently in countries where they are working.

As a result, we have been able to continue, and increase financially, our collaboration with Calala-Fondo de Mujeres, relying on their knowledge of Spain to ensure that our funding is allocated in the most relevant way possible.



This year, we also resumed a similar collaboration with Ecumenical Women's Initiative, a Croatian fund, to provide effective support for the managerial transition of a women's organization based in Bosnia-Herzegovina.

In addition, our close and trusting relationships with the Global Fund for Women and the African Women Development Fund have led them to ask us to continue acting as intermediaries for funding organizations in North Africa.

Collaboration around projects

We are actively collaborating with two European funds on two projects:

- The "**Knocking on EU's doors**" project, coordinated by the MWF and the Ecumenical Women's Initiative. Our advocacy expert has continued to open doors for us with the European Union, and we can say that the EU's doors finally opened for feminist funds in 2022. (See advocacy chapter)

Under this project, the MedWF and Calala Fondo de Mujeres (with the invaluable help of Ecumenical Women's Initiative and our advocacy expert) have won a grant under the European Union's Erasmus+ program for a project entitled, "Achieving gender equality through the feminist funds model: empowering grassroots women's organizations". Its main aim is to reinforce the work carried out by European feminist funds by enabling them to discuss their methods and increase our visibility and expertise within public and private institutions.

This resulted in a report highlighting the role and funding principles of feminist funds, to which thirteen feminist funds from Prospera's European chapter contributed. It is the fruit of numerous interviews with each of these funds, several virtual meetings and two workshops to reflect on the financial assistance and general support that the funds provide to women's associations. It demonstrates the importance of our grant-making model, and our experience in supporting and evaluating associations in the field.

- The "On the Right Track" project, the first collaboration between Prospera's European and Latin American chapters to combat the rise of fundamentalism and the far right, has continued into a second phase, notably through the awarding of grants and the creation of a feminist monitoring and evaluation framework within the project. This second phase also included an external evaluation, to enable us to better define our future activities.

In addition, we continued our collaboration with feminist funds around the world as part of a group working on the feminist crisis ecosystem, entitled "Feminist Alchemy", i.e., the way feminist funds set up financing to respond to emergencies linked to economic, political, security, environmental crises, etc.

The objectives in 2022 were mainly to share our work as feminist associations and funds on emergency grants, to discuss ways of responding to crises, lessons learned and perspectives for the future.

These points were discussed collectively in Mexico City and regularly in several online meetings throughout the year. Among the group's activities, surveys were carried out to contribute to research on trends and gaps in feminist work in relation to crisis response, and a toolbox was produced. The aim of the research is to build a model of feminist crisis response and, where possible, to highlight the differences between traditional humanitarian response and crisis response with a feminist approach.

2. Collaboration with other human rights and development foundations

· Through networks

The MedWF also is a member of numerous donor networks involved in human rights and/or development (Edge, Ariadne, Centre Français des Fondations, etc.). The meetings organized by the networks are held fairly frequently and are all interesting; we meet people with experience in our field and have the opportunity to discuss potential collaborations.

After almost two years without seeing each other in person, the donor network meetings resumed this year, and we were able to take part in several of them:

- Ariadne's "Great reconnect" in April, in Lille: one of our members was part of the organizing committee and was "Philosopher of the day", another spoke during a reflection on the failures we may have experienced;
- The European EDGE meeting in Cassis in May: our member of the network's European Steering Committee was also involved in organizing the meeting;
- The annual meeting of PEX (a branch of the Philea network) in August in Istanbul, entitled "Driving change in (eco)systems: exploring the transformative power of collaboration in philanthropy".

· Or individually, on a project

We continued our collaboration with the Calleva Foundation, helping it to identify projects in Lebanon and Morocco that corresponded to its areas of interest, and then acting as an intermediary. Further affirming its confidence, the Foundation has even increased its financial support.

Similarly, we also continued to support French and Italian associations as part of our partnership with the Kering Foundation to support associations working to combat violence against women.

3. Advocacy for more funding to associations

This year, we strengthened our advocacy efforts, both at the national and international level.

In France

In 2022, the MedWF continued to invest in advocacy actions:

-Within the Collectif Générations Féministes (CGF), a group of 70 associations whose aim is to integrate feminist approaches into public policy. For example, during the French presidential elections, the CGF compared the platforms of the various candidates regarding the issue of women's rights and, in particular, the fight against gender-based violence. During discussions with certain candidates, the collective paid particular attention to financial commitments on the various themes. At the same time, the collective continued its discussions with the Chairman, Delphine O, to take stock of France's commitments following the Generation equality Forum.

-Within the "Feminists in Action" consortium, financed by the French Development Agency, to simplify procedures for civil society organizations applying for funding.

-The MedWF continued to contribute to the consultation group attached to the steering committee of the Fund for support to feminist organizations (FSOF). This group is made up of civil society organizations, the French Ministry of Foreign Affairs and the French Development Agency. The FSOF is a funding mechanism launched in 2021 to support feminist organizations locally in countries of the global South. The consultation group has taken part in FSOF scoping meetings and mid-term evaluation meetings since its inception. Among the victories achieved by feminist NGOs and organizations: the renewal of the FSOF (which was due to expire in 2024). This investment continues to give us greater visibility in France, especially in our advocacy work, with the aim of increasing and better targeting the resources granted by major public institutions to feminist organizations.

In the area of private philanthropy, the MedWF continues its mission of advocating towards funds and foundations in France. They are in effect reluctant to make a greater commitment in this area, even though all of them, without exception, recognize that this issue is essential and that efforts need to be made, including within their governance bodies, regarding parity, for example.

This is why the MedWF joined forces with Fondation CHANEL, the Fondation de France and the Raja Foundation to launch a new Gender Equality Coalition. It aims to raise the profile of this topic among funds and foundations in France, and thus mobilize more resources in favor of this cross-cutting issue, whatever the foundation's primary purpose.



Internationally

The women's funds are playing an essential role in the development of advocacy efforts aimed at convincing major institutions and various philanthropic organizations (foundations, corporations, philanthropists, institutions, etc.) to provide greater support to the woman's movement around the world.

We therefore continued our efforts with the European Union, further developing the "Knocking on EU's Doors" project, aimed at convincing the European Commission of the importance of funding feminist funds and organizations, and facilitating access to funding dedicated to gender equality. For several years now, the European Union has been pursuing two major strategic initiatives in the field of gender equality: in internal EU policy, the European Strategy on Gender Equality, and in external policy, the Gender Action Plan, the results of which have fallen short of expectations. The MedWF and Ecumenical Women's Initiative, who coordinate the project for the European feminist funds, worked intensively with their advocacy expert to establish communications and connections with key institutions, working groups and advisory committees, both at the European Commission and among members of the European Parliament.

In 2022, the activity program and impact of European feminist funds can be summarized in three main areas:

- **Advocacy**: European feminist funds have engaged with over 25 officials from European institutions, including five special advisors (the most senior officials), the European Commissioners for Equality, Values and Transparency and International Partnerships, as well as the President and coordinators of the Committee on Women's Rights and Gender Equality (FEMM), the most influential mechanism for developing gender equality legislation in Europe.
- Partnership development: We testified twice before the European Parliament's Committee on Women's Rights and Gender Equality (FEMM) and the Council of European Municipalities and Regions, Europe's largest organization of local and regional authorities. Members include 60 national associations of towns, municipalities and regions from 41 Council of Europe member countries.
- **Networking**: in 2021 and 2022, European feminist funds contributed to a handbook of best practice on gender budgeting written by the European Institute for Gender Equality (EIGE), the leading gender equality research agency. This handbook has served as the basis for several studies bringing together tools and methods that have helped EU institutions and national authorities to use EU funds in shared management with feminist civil society partners. Les fonds féministes européens ont établi un partenariat solide avec Women.

The European feminist funds have established a strong partnership with Women Against Violence Europe (WAVE), a network of over 160 European women's NGOs working to prevent and protect women and children from violence. As an example of this cooperation, the European feminist funds organized a joint webinar in May 2022, which attracted over 60 participants from organizations across the EU on the Gender-Based Violence Directive. This platform led to an official invitation to take part in the European Parliament's expert consultation on the directive, and to the submission of amendments which were adopted in committee. We also worked with WAVE on the development of a multi-regional pilot project led by feminist funds, which is an official recommendation to the directive on gender-based violence to be voted on by FEMM members in March 2023.

B. Strengthening the organization

1. Consolidating the team

By "team", we are referring to both the salaried staff and the members of the Board of Directors (including the Executive Committee) of the MedWF, because the salaried team receives considerable support from the members of the Board of Directors, who come from complementary backgrounds and are both highly committed and highly experienced. They dedicate considerable amounts of their time to the development of the MedWF, including operational tasks (follow-up donations, website, database, fundraising), strategy and above all outreach. Thanks to them, the MedWF has begun to build up a receptive audience in public and political spheres, particularly in France.

The Board of Directors is made up of Marta Giral, Christine Buttin, Samia Salhi, Fawzia Baba-Aissa, Axelle Maldidier, Alya Cherif Chamari, Fatem-Zahra Bennis, Laura Jovignot, Mathilde Mondon and, as of this year, Sarah Swaydan, our former Grantmaking Program Officer, who continues to contribute her expertise.

At the end of 2022, **the team** included nine salaried staff, six of whom work part-time to a greater or lesser extent, and a part-time consultant for advocacy and development, bringing the total to 7.67 FTE. The size of the team is finally starting to match our ambitions and the amount of work that we have to do, and the team is becoming increasingly solid, well-organized and autonomous. Its rejuvenation, begun in 2017, continued this year with the hirings of Lamia Batata and Amy Elshaarawy, both managing relations with associations.

2. Drawing up the 2023-2027 Strategic Plan

With 2022 marking the end of the 2018-2022 Strategic Plan, we organized a series of in-house meetings, either by thematic sub-groups, or bringing together the entire team and the Board of Directors, to take stock of the 2018 Plan and map out future strategies. This required a great deal of extra work on the part of the team, which was critical both for our evaluation system and to share with new team members the vision and reasons behind the management choices we make.

3. Self-care workshops

We have always placed collective and individual well-being at the heart of MedWF's operations, and have been thinking for some time about how to formalize this. The COVID-19 pandemic and the impact it has had on our bodies and minds while we were isolated, locked away, working from home, prompted us to develop a self-care program with our partner Nadia Aïssaoui. It combines reflection, discussion and advice on this theme, but also practice, to help us reconnect with our bodies and strengthen them in the face of everything we put them through on a daily basis, especially sitting in front of a screen all day long.

The MedWF team is experimenting with this program, developing it as it goes along, with a view to offering it to women's associations that take too little time for themselves. This year we systematically organized a session at each of our face-to-face meetings in Paris, unless our travel schedule was too full. These moments were an opportunity for each of us to take some time for ourselves, but also, by sharing a non-work activity, to cement the bonds within the team. While there was no obligation for those who did not wish to take part in physical activity, they were strongly encouraged to take this time for themselves. We feel it is important to incorporate this regular, very positive and instructive group practice into our programme in the years to come.

4. The Friends of the Fund

To successfully carry out its activities, the MedWF has gained growing support as time goes by, and we are gathering around us an increasing number of people who wish to contribute to our efforts.

We rely first and foremost on the availability and commitment of the members of the Board of Directors, who give a great deal of their time and expertise, especially as we work on the future Strategic Plan. We also have the support of an ever-growing number of "Friends of the Fund", who offer their know-how, time and energy, make their homes, cars and equipment available, forge links and thus enable the team to multiply its activities tenfold.

Among them are translators, artists, consultants, trainers, graphic designers, IT specialists and other support services providers who are not only highly skilled, but often do part – or all – of the work on a pro bono basis.

We particularly appreciate their immense contribution on occasions such as training sessions and meetings, but also in a very significant manner for different consultancy services.

It was undoubtedly this support that enabled us to make a qualitative and quantitative leap forward in the development of the Mediterranean Women's Fund.






